ACDC's 2026 Business Improvement Grant Program

Through our Business Improvement Grant program, we've been able to assist with over 182 different projects throughout our county since 2013. We designed this grant program so that we would have a structured way to help local businesses, but we also wanted to encourage their continuation, growth, and development. Over the past 13 years, we've seen an infusion of over \$347,000 back into our local economy in the form of goods and services from AC vendors. Grant recipients have invested in themselves and leveraged nearly \$211,000 in ACDC funds (county sales tax dollars allocated to this office via the 1/4-cent economic development sales tax) to complete over \$1,068,000 worth of improvements!



We have loved utilizing this grant to assist our amazing businesses, and we need your help to promote this opportunity! If your business has benefited from this program, would you encourage a fellow business to reach out to us? If you know of a business with a project coming up, please remind them of this specific tool that is designed to assist with something that *they* need to better their business!

In 2026, ACDC will offer two levels of funding through this reimbursed matching grant program on improvement projects for existing businesses.

- **BASIC:** grant will equal up to 50% of the cost of eligible improvements, max. \$1,000. (If total project cost is \$1,200: ACDC's reimbursed grant is \$600 + business pays \$600. If total project cost is \$2,200: ACDC's grant is \$1,000. Business pays \$1,200.)
- **2.0:** grant will equal up to one-third of the cost of eligible improvements, max \$2,500. (If total project cost is \$7,500+: ACDC's reimbursed grant is \$2,500. Business pays \$5,000+.)

ACDC could award up to \$20,000 in funds during the 2026 grant cycle. Applications will be accepted via mail (or at the ACDC office at 321 S. Main St. in Rock Port, via mail slot in door if the office is closed) after January 15, 2026. Eligible projects must be approved prior to beginning work. Completed applications will be considered in the order they are received. Contact ACDC for an application or more information.

This grant program assists with community cleanup and beautification projects in our county. So far, projects have included planting trees, installing a flagpole, and adding a swing in a new public flower garden spot, but the possibilities are endless!

Successful CC&B grant projects

- are carried out by community volunteers;
- utilize local businesses, vendors and services (whenever possible!);
- and beautify a visible, public area in AC.

ACDC will fund up to \$1,500 total in CC&B grants in 2026, with grant awards ranging from \$25 to \$500. This is a first-come, first-served grant, with applications considered in the order they are received. Contact us today for an application!

Did you know ACDC supported nonprofit efforts in 2025?

ACDC supports nonprofit projects and efforts around the county. Each year we are the primary sponsor for the countywide Battle of the Books event, we support Northwest Missouri Enterprise Facilitation (one of our favorite partners when working with new and potential businesses!), and we provide a scholarship to an AC resident attending Leadership Northwest. In addition to those expenditures in 2025, we also supported projects with the Tarkio Board of Public Works and the Fairfax Fire Department.

We have a small grant program in place for the efforts of nonprofits and volunteers in our county, particularly for projects that add or retain jobs or services, increase tourism, or improve local recreation opportunities. ACDC Scholarship Applications: due March 27, 2026

ACDC's annual scholarship program was created to help outstanding AC graduates pursue post-secondary education and training that can help them to create a good life (here, if we're lucky!). ACDC offers a \$1,000 award to one student from each high school in each of the following categories, for a total of two scholarships per school district area:

- community college or technical training program
- 4-year undergraduate degree

Applications are available in each high school counselor's office and online at www.atchisoncounty.org/education. Applications (including a brief essay) and transcripts are due to ACDC by 3pm on Friday, March 27.

Great Northwest Day at the Capitol - February 3-4, 2026



Great Northwest Day originated as a project of the 2001-2002 classes of Leadership Northwest Missouri as a way to promote awareness of our region in Jefferson City. This unique regional education effort is organized by leaders from the nineteen counties in the best corner of the state, who work cooperatively to promote our region and pursue legislation that is beneficial to our citizens.

The event includes introductions of the delegation on the House/Senate Floors, education on legislative priority issues, and breakfast with a keynote speaker. Prior to the main event on Tuesday evening (where Atchison County will have an amazing booth!), the Northwest Missouri Reception will include regional legislator updates and the presentation of the Northwest Missouri Citizen of the Year Award.
